**Parking Rules and Regulations at INVESCO Field at Mile High**

### **Season Parking Permits**

To request season parking please fill out the parking request card that you receive at the end of each season along with your season ticket renewal package. Parking requests must be submitted by the first business day of March each year. Parking is sold based on availability and priority number. A limited number of permits are to still available for the 2009 season.

### **Hours of Operation and Access**

- All permit parking areas open five (5) hours prior to each game.
- First come / first serve tailgating in Lot C will open at 8AM for afternoon games and 12PM for evening games.
- Please follow the suggested access routes identified on the back of your permit or you may be denied access and redirected by traffic officers. A map and directions to all lots are also available at [www.invescofieldatmilehigh.com](http://www.invescofieldatmilehigh.com).
- You must have a valid permit for the current game number. Games are numbered #1 through #10, beginning with the first preseason game. Vehicles without valid permits, regardless of reasons, will be denied access to the permit lots. Permits for 2009 playoff games will not be included in your permit package.
- The permit must be displayed conspicuously on the rearview mirror of the vehicle with the game number and lot letter visible while parked.
- There are NO in-and-out privileges. Once your vehicle has entered the parking lot, the permit will not be accepted again for entrance.
- Vehicles must be parked in marked parking stalls, parking along curb lines or taking up more than one parking stall without the correct number of permits may result in your vehicle being impounded, termination of your parking privileges and cancellation of your season tickets.
- Tailgate parties are allowed and encouraged. Tailgaters should pay special attention to the section below entitled "Tailgating Policies." ### **Handicap Accessible Parking**

Handicap accessible parking for all Broncos games for those without pre-purchased parking permits, is available on a first come / first serve basis in parking Lot L located on the north end of the stadium. Parking Lot L is sold only on a cash-only basis on day of game; the fee for parking is \$20 with the lot opening five hours prior to game time. Historically, Lot L has sold out one to two hours prior to game time, so please arrive early.

A limited number of handicap accessible parking spaces for those without pre-purchased parking permits, will additionally be available on a first come / first serve basis in Lots D and G located on the southwest and northwest sides of the stadium. The parking fee for Lots D and G is \$30 with the lots opening five hours prior to game time. It is strongly recommended that you arrive no later than one hour prior to game time as all

day of game handicap accessible parking spaces sell out early and on a first-come, first served basis.

### **Handicap Accessible Parking – Single Game Permits**

A limited number of single game permits may be available for handicap accessible parking in Lot G; the parking fee is \$30 per game. Those wishing to purchase a single game permit for handicap accessible parking should call 720-258-3000 or email [Parking@Broncos.NFL.net](mailto:Parking@Broncos.NFL.net). Single-game permits if available, are sold on a first-come, first-served basis and will only be sold to those who may supply a copy of a valid State-issued handicap placard or vehicle registration.

### **Handicap Accessible Parking – Season Permits**

Handicap accessible parking is currently available on a season long basis in Lots D and G. The parking fee for both lots is \$300, to apply for season parking in these lots please fill out and return the parking request form that you received with your season ticket renewal package along with a copy of your vehicle registration or State-issued handicap placard. The deadline to submit season parking requests is the first business day of March each year.

### **Shuttle Cart Service**

Shuttle carts for elderly and disabled patrons will begin operating three hours prior to game time and service will continue until one hour after the game ends. Patrons who desire to be picked up from the parking areas must arrive early and depart at least one hour prior to game time. Patrons who desire to be transported back to their vehicles after the game must wait until walkways have cleared.

All shuttle patrons will be dropped off or picked up only at the designated shuttle stop points along the ring walkway. Please do not hail empty carts that drive by, as they are in route to pick up waiting patrons at the designated pick up points. In order to help get you to your car as soon and safely as possible, shuttle drivers are instructed not to stop for pick-ups along the way, so they can get to the pick up points quickly.

During inclement weather, the shuttle cart service may run on an extremely limited basis or not at all.

### **Tailgating Policies**

Tailgating is allowed and encouraged in all stadium parking lots. The Denver Broncos value your enthusiasm and the following policies are established to ensure that all tailgate parties are safe:

1. Occupy only ONE (1) parking space per vehicle.
2. Tailgate directly behind your vehicle or in an adjacent landscaped area ONLY.
3. Maintain a 14' drive aisle between rows of vehicles at all times (for a fire engine, if necessary).
4. Barbeque grills are allowed. Open-flame fires are not allowed.
5. Dispose of charcoal in designated coal barrels only.
6. All tailgate parties must conclude 30 minutes prior to kickoff.

## **NOT ALLOWED**

Be aware that fans are subject to citation, arrest and loss of season parking and season tickets if found in possession of, or participating in, the following:

- Glass bottles
- Kegs
- Sales or distribution of products, food or beverages
- Advertising or promotion without advance, written approval by the Denver Broncos
- Open-flame fires
- Blocking of pedestrian aisleways, sidewalks or disabled access aisles
- Blocking or saving parking spaces. Fans who wish to tailgate together must arrive together.
- Unauthorized vehicles operated within the stadium parking lots or walkways; including, but not limited to: Go-karts, mini-bikes, or Go-peds.
- Unauthorized use of stadium property

### **Parking Transfer Policy**

- Season parking permits may only be transferred to another account, if the entire account is transferred as allowed by the Stadium Management Company, LLC. Club Seat Season Ticket Assignment Form.

### **Commercial Activities**

Commercial activities of any kind in the parking lots and on stadium property are strictly prohibited without prior written permission from Stadium Management Company. Violators are subject to citation, arrest, loss of parking privileges and loss of event tickets.
